## LINKING LANDHOLDERS

*Di Lewis reports*

Liz Barraclough presented BERG's work to an audience of over a hundred landholders at the recent Mornington Peninsula Land Management Expo organised by the Peninsula Pastures and Produce program on Sunday 20<sup>th</sup> May at The Briars.

The aim of the PP&P program is to help landholders manage their land as effectively as possible, and connect them with local support, advice and funding assistance.

Liz was one of twelve speakers from government, private landholders and friends' groups addressing issues of agriculture in the Mornington Peninsula and Western Port Biosphere reserve, waterway health and biodiversity, and protecting the coastal environment.

BERG committee member Tony O'Connor's Century Drive property was held up by Jacqui Salter, the Shire's Landcare Facilitator, as an example of what private landholders can do. Tony is the driving force behind the Century Drive Habitat Link group, and has established wonderful wetlands on his land and in the Century Drive retarding basin, adjacent to Balcombe Creek.

Liz and other BERGers also manned a booth providing information about BERG's work.

## WILDLIFE CORRIDORS

*from Liz Barraclough*

What remains of the Mornington Peninsula's regional fauna is under real threat of extinction. A number of organisations are working to combat this threat by forming wildlife corridors or 'biolinks' throughout the Peninsula.

The aim is to connect areas of existing bushland and engage the community, landholders and landcare networks in the process. Those interested will be given practical information on how to develop and manage biolinks projects, get the community on board, and build the skills and resources needed.

### **A pilot corridor**

The Devilbend Foundation is being funded by the Natural Resources Conservation League of Victoria to develop a pilot corridor and is currently looking at where this might be located. Possibilities are towards Balcombe, Warringine or Greens Bush.

## FIELD NEWS

*Field Officer Liz Barraclough reports*

### Working bees

In **March** a small, select group of five (quality if not quantity!) did a great job removing Flax-leaf Broom seedlings and large Polygala from the foreshore between the Yacht Club and Bay Road.

In **April** we returned to the area we weeded in February, in the vicinity of where Victoria Cres joins the easement to the Esplanade. We continued with a satisfying onslaught on what was, before our efforts, rampant Polygala, and also removed Boneseed, Pittosporum, Cotoneaster and Broom.

In **May** another small, select group – six this time – planted along the foreshore reserve between the south carpark and Bay Road. With our earlier plantings here and removal of woody weeds, the area is looking good.

At the **Hopetoun Creek** working bee in May, despite being an even smaller group, we planted 34 shrubs and trees and 40 sedges.

The **Friday Morning Group** is back working near Uralla Bridge, continuing our weed control here. The recent rains have flooded many of the regenerating weed seedlings away, but on higher ground they have proliferated. We hope we have caught them before

they have had time to seed.

A few weeks ago Sally McCleod, leader of the Naturelinks Team, tutored us in using the weed burner. The Shire requires us to have this training so they can issue us with permits for weed burning.

### Grants

We have been awarded three 2012 Melbourne Water Community grants.

- A **Group Support Grant** of \$1,100 will enable two more BERG members to undertake the Mornington Peninsula Habitat Management course, further extending our base of expertise.
- We have \$15,064.50 to follow up our previous work along **Hopetoun Creek** with control of woody weeds, selective spraying and hand-weeding of scrambling and groundcover weeds, enhancement planting and community awareness activities. The

work on the eastern bank will extend from the kindergarten to the reed swamp, and on the western bank, will be in the riparian section behind St Ives Ave and Hopetoun Ave.

- We have \$18,543.50 to follow-up and consolidate our work on both sides of **Balcombe Creek** from the Uralla Rd bridge for 100m towards the sea. The work will comprise planting and community awareness activities.

Applications are in for:

- a **Community Action Grant** to restore two threatened areas: a riparian section of Swamp Melaleuca and adjoining grassy woodland on the north side of the creek between the Augusta St and Uralla Rd bridges, and the Hyacinth Orchid area on the western side of the track at the eastern end of the Ferraro Ovals;
- a **Caring for our Country, Coast Action Coastcare Grant 2012–13**, primarily for essential weed follow-up of the foreshore north of the bridge between the carpark and the bottom of Coolangatta Rd.

#### Upgrading the signs in the reserve

New signs have been promised for months, but we are nearly there! Posts with small directional plaques are in place (see photo), and the new interpretive signs and map are printed and will very soon be installed by members of the Mount Martha Rotary Club.

#### Monitoring our birdlife

Inspired by a Birdlife Forum I attended in April with BERG members Pam Hearn, Ros Crompton and Sue Betheras, we are organizing a seasonal bird monitoring program in the Balcombe Estuary Reserves.

The forum focussed on the relationship between birds and their habitat, the decline of species, and restoration of habitat. It was

emphasized that the prevalence of birds, the species present and their behaviour are sensitive indicators of ecosystem health.

We hope, through our monitoring program, to provide ongoing data to help measure the effects of our work in the Reserve and alert us to problems.

### NEWS FROM THE BRIARS

#### Dwarf Galaxias relocated

About 700 these endangered native fish have been relocated from the path of Peninsula Link to the Crake Pond at The Briars. The pond is free of Mosquito Fish, an introduced species which threatens Dwarf Galaxias, and it provides excellent plant cover. Ongoing surveys have revealed prolific breeding by the 'dwarflies'.

#### Board walk along Harrap Creek

Liaison continues with Melbourne Water on erosion control and revegetation of Harrap Creek. Agreement was reached on the route of the proposed boardwalk across the Creek to provide access to Craigie Road and the shared path network to the north. A Cultural Heritage Management Plan and Environmental Management Plan are needed before work can start.

## ESTUARYWATCH

### John Inchley reports

**B**ERG has been asked by Melbourne Water to trial EstuaryWatch, a new community-based estuarine monitoring program.

EstuaryWatch was initiated in 2006 with the Corangamite Catchment Management Authority. Trials have now extended to the Port Phillip and Westernport catchment, initially in the estuaries of the Balcombe and Merricks creeks. BERG's involvement will build on our ten years' activity in the WaterWatch program.

The aims of EstuaryWatch are two-fold: to raise community awareness and understanding of estuarine environments, and to support better decisions about and management of estuaries.

A BERG EstuaryWatch group will take regular samples of water in the estuary from specific locations to measure water quality (as we already do further up the creek in WaterWatch). We will also take photos over time from a point at the estuary mouth, using BERG's new purpose-bought camera.

**THE WATER DRAGON IS STILL ABOUT**

It was February last year when we first reported sightings of a handsome Gippsland Water Dragon in the reserve, probably a dumped pet.
